# **Center for Excellence in Investment Management**

# Finance Development Program (FDP)

#### **PNC Capital Markets Lab**

Students hone key skills of financial services professionals in this state-of-the-art learning environment. With 20 Bloomberg terminals and access to other resources such as Factset, the lab provides a real-world setting for students to manage equity and fixed-income portfolios.

# **EXPERIENTIAL LEARNING**

#### **Projects for Investment Management Experiential Learning (PRIME)**

This unique offering provides students with the opportunity to gain breadth and depth in the investments industry. The course works with ~16 investment firms supporting students in their spring projects and prepares them for summer investment management internships, which will help them secure full-time jobs.



#### **Alpha Challenge**

Hosted annually by the Center, this two-day competition is one of the world's premier investment pitch competitions. Teams from top business schools pitch investment recommendations to an acclaimed group of buy-side investment professionals. The event brings together over 70 top investment management firms, which offer interviews and networking opportunities.

#### **Student-Managed Funds**

Students manage live portfolios in public securities through the Global Perspectives hedge fund, a private equity fund, and a real estate fund, developing tangible skills in global macroeconomic asset allocation, portfolio management, and investment communication.

#### **National Investment Pitch Competitions**

Students apply their knowledge and network with peers and professionals at company-sponsored competitions, which provide opportunities to apply industry and technical knowledge and to showcase strategic thinking and presentation skills to potential employers.

#### **Investment Management for All: Wealth & Women**

The Investment Management industry can be intimidating from the outside, particularly for minority populations. This annual event helps to address these barriers through networking, workshops, group and individualized pitch coaching, and informational chats — exposing students to the different career paths within the industry and the nuances of each.

Introduction to Excel & Financial Modeling: Introduction to efficient Excel navigation and building dynamic financial projections and modeling.

Corporate Valuation and M&A Strategy: Fundamentals of key valuation methods including comparables company analysis, discounted cash flow, merger analysis and leveraged buyout analysis.

Interview Prep: Investment Banking and Private Equity: Prepares candidates for the "fit" and technical portions of the investment banking and private equity interview.
