
FINANCE AREA OF EMPHASIS: PLANS OF STUDY

HOW IT WORKS

The Area of Emphasis (AOE) in Finance equips students with the essential skills and knowledge to pursue careers in a variety of financial sectors. 9 credit hours of dedicated coursework is required for completion. This program offers five specialized tracks, each designed to align with specific career aspirations within finance.

While you may take more than 9 credits of finance electives, we encourage you to also explore other business courses.

Careers in finance benefit not only from strong technical skills but also from communication, negotiation, and teamwork abilities. Electives in areas like management communication, marketing, entrepreneurship, and organizational behavior can help you build a well-rounded skill set.



CORPORATE FINANCE

Corporate finance focuses on financial strategy, capital budgeting, and financial planning within organizations. This strategy arm helps companies spend money wisely.
